- The Internet sale takes place using a simple, clear, step-by-step process, such as those known from hotel booking platforms.
- The service doesn't require a complex installation or local programs – a standard Internet access is sufficient.

Increase sales through an additional sales channel

- Integrate the service into your website and your social media presence and address new and previously unreached customer groups.
- Generate without increased effort additional revenue.

24/7 online service for your customers

- Your Internet sales service is not bound to office opening times and is therefore available to your customers anytime and anywhere.
- Monthly rents can be automatically collected, for example, from the credit card account given by a customer.





Features

Use and application

- The operator offers customers the option of making a long-term (contract-based) parking space reservation over the Internet
- The customer generates a request for the desired parking product via 'sweb.Contract B2C'
- The operator confirms the request and
 - provides the requested data carriers
 - Alternative: The customer specifies existing data carriers when submitting the request
- The customer is notified via e-mail about the activation,
- including information about any follow-up steps • The customer receives the requested data
 - carriers (by e-mail or personal collection) - Alternative: Customers using existing data carriers may use the parking space straight away
- The monthly rental fee is charged automatically to customer, • which is then debited from the payment account on file (bank account or credit card)
